REVISION TO TAX GRIEVANCE HEARING CODE OF CONDUCT

Prior to the meeting BCA members were presented revisions to the Tax Grievance Code of Conduct Policy. Minor changes included changing the word Listers to Assessor, and increasing the oral presentation time from 3 minutes to 10 minutes. Most of the time was spent discussion Ex-parte Communications. The intent is to clarify the Inspection Committee's right to discuss the appeal for the purpose of writing their report and to contact the appellant to set up the site inspection date and time.

On a motion by JP Isabelle, seconded by Tracy Delude, the Board of Civil Authority voted unanimously to adopt the Tax Grievance Hearing Code of Conduct policy with the amendments discussed during the meeting.

APPOINT JPS TO CARRY SICK BALLOTS

By consensus of those present Chris Violette and Guy Isabelle were appointed to carry sick ballots on March 4, 2014 and Lee Walther and William Bugbee as alternates.

OTHER BUSINESS

A). During the last Board of Abatement meeting there was discussion as to whether or not an individual giving testimony should be required to take an oath. The Town Clerk checked with the Secretary of State's office and the VLCT. Both entities stated that while it does not require individuals appearing before the BCA at an abatement meeting to take an oath it would be good practice to do so.

Discussion followed on perhaps having a Code of Conduct for Abatement Meetings (just as we currently do for Tax Grievance hearings). JP Isabelle and Lee Walther will work on preparing a draft policy for later review.

- B). The Election calendar is as follows: School Election March 4, 2014; Town Caucus on March 17, 2014, May 7 at 6:00 p.m. a checklist update meeting followed by the Open Town Meeting; and the Barre Town Annual Elections on May 13, 2014.
- C) The Clerk informed the BCA there is legislation to change the Primary Election date from the last Tuesday in August to the first Tuesday. There is a good chance if the bill passes that it will become effective in August 2014. This presents a problem as the Town Clerk will be out of state at that time. Town Charter states that in the absence of the Town Clerk the BCA will elect one of its members to be the Presiding Officer. This would mean additional, quick training for the member selected.
