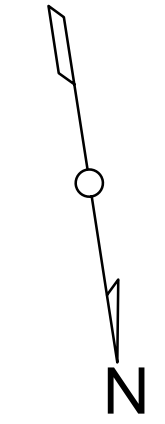


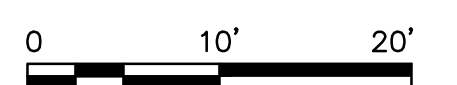
- LOT NOTES:
1. NO RECORDS COULD BE FOUND TO DOCUMENT OWNERSHIP OR FAMILIES BURIED AT WEST HILL CEMETERY. THE SCHEMATIC DEPICTION OF ANY LOT OR THE ADDITION OF ANY NAME DOES NOT AUTHENTICATE ANY CLAIMS OF OWNERSHIP.
 2. ONLY ONE LOT, MARKED AS "MURPHY, ROBERT," HAS BEEN LAID OUT WITH CORNER POSTS. NO OTHER MARKERS OR STONES ARE IN THIS LOT. THE CEMETERY COMMISSION AMENDED THE BARRE TOWN CEMETERY REGULATIONS IN 2013 TO PROHIBIT ANY FURTHER BURIALS AT THE WEST HILL CEMETERY OTHER THAN BY THOSE WITH PROPER LEGAL DOCUMENTATION OF LOT OWNERSHIP AND THE LOT CAN BE PROPERLY LOCATED WITHIN THE WEST HILL CEMETERY.
 3. AN ATTEMPT HAS BEEN MADE TO TRANSCRIBE THE MONUMENTS THAT STILL EXIST. SEVERAL HAVE BECOME VERY DIFFICULT TO READ, SOME NO LONGER SHOW ANY TEXT AT ALL.
 4. THE LAYOUT OF THE CEMETERY IS A SCHEMATIC INTERPRETATION OF THE SITE. THE SCHEMATIC HAS BEEN PREPARED BY CEMETERY COMMISSIONER DWIGHT D. HARRINGTON COLLECTING MEASUREMENTS IN THE FIELD AND ARRANGING THE EXISTING STONES ON PAPER IN RELATION TO THE CEMETERY BOUNDARY LINES.
 5. THE DEED FOR THIS CEMETERY CAN BE FOUND IN THE "OLD" DEED BOOKS FOUND AT THE BARRE CITY CLERK'S OFFICE IN BOOK 3, PAGE 63. AT THE TIME OF THE DEED, 1804, THE CEMETERY HAD THE NAME "MOWER CEMETERY" AS THE TOWN PURCHASED LAND FROM THOMAS MOWER.
 6. THE CEMETERY BOUNDARY HAS BEEN MARKED WITH A WIRE FENCE ON THREE SIDES, THE WIRE HUNG ON GRANITE FENCE POSTS, AND A WROUGHT IRON FENCE ON THE PERRY ROAD SIDE.
 7. FOR FURTHER INFORMATION ON SOME OF THE FAMILIES BURIED WITHIN THE CEMETERY, SEE OTHER FILES LISTED ON THE TOWN OF BARRE WEBSITE.
 8. IN JUNE OF 2016, THE FLAGS FOR VETERANS ORGANIZATION RECEIVED PERMISSION TO PLACE A GRASS MARKER AT THE PROBABLE LOCATION OF THE GRAVE OF ENOS TOWN, A VETERAN OF THE WAR OF 1812. THE LOCATION IS SHOWN ON THE SCHEMATIC AS "PLACED BY FFV."

AT THE REGULARLY SCHEDULED BARRE TOWN CEMETERY COMMISSION MEETING HELD ON 27 SEPTEMBER 2017, THE COMMISSIONERS FORMALLY ADOPTED THIS SCHEMATIC REPRESENTATION OF THE WEST HILL CEMETERY AS THE OFFICIAL SCHEMATIC OF THE CEMETERY TO BE USED FROM THIS DATE FORWARD BY ALL PARTIES IN ANY WEST HILL CEMETERY BUSINESS. ELECTRONIC COPIES OF THIS SCHEMATIC HAVE BEEN FURNISHED TO THE BARRE TOWN ENGINEER IN BOTH PDF AND DWG FORMATS.
