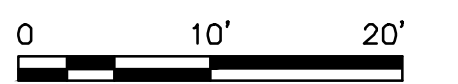

8. DEEDS FROM THE BARRE TOWN CEMETERY DEED BOOKS AND FROM THE BARRE TOWN AND BARRE CITY LAND RECORDS.

**DEEDS USED:**

- A. SEVERAL DEEDS FOUND IN THE CLERKS' OFFICES OF BARRE CITY AND BARRE TOWN HAVE BEEN USED TO PREPARE THIS SCHEMATIC AS LISTED BELOW:
- B. BOOK 1, PAGE 207 IN THE CITY CLERK'S OFFICE: NICHOLS TO THE TOWN OF BARRE, DATED 16 MARCH 1797. THE DEED SHOWS A PURCHASE PRICE OF \$6.66 FOR ONE ACRE AND REPRESENTS THE ORIGINAL BURYING GROUND NOW CALLED WILSON CEMETERY AND SHOWN AS OLD YARD 3 AND OLD YARD 4 IN THE CURRENT MAPPING. ABUAH ABBOTT REFERRED TO THIS PROPERTY AS THE NICHOLS CEMETERY IN HIS WRITINGS, GOING AS FAR AS DENOUNCING THE NAME WILSON CEMETERY ONE OF THE PAGES OF HIS GENEALOGY. THE DEED DESCRIPTION REFERENCES THE THOMPSON PROPERTY CALLED FOR IN THE DEED CALLED FOR IN NOTE C, BELOW.
- C. BOOK 25, PAGE 66 IN THE CITY CLERK'S OFFICE: THOMPSON TO THE TOWN OF BARRE, DATED 18 AUGUST 1888. THE TOWN BOUGHT THE LAND FOR \$325 FOR A BIT MORE THAN TWO ACRES. SECTION A THROUGH SECTION E ARE COVERED BY THIS DEED.
- D. BOOK 10, PAGE 46 IN THE BARRE TOWN CLERK'S OFFICE: WALTER A. SMITH TO THE TOWN OF BARRE, DATED 26 SEPTEMBER 1907. THE PRICE IS SHOWN AS \$120 FOR 1.2 ACRES AND THE DEED CONTAINS A BEARING AND DISTANCE DESCRIPTION OF THE PARCEL. THE CUTLER PROPERTY IN THE DEED BELOW IS REFERENCED. CEMETERY SECTIONS NORTH AND F ARE COVERED BY THIS DEED.
- E. BOOK 10, PAGE 78 IN THE BARRE TOWN CLERK'S OFFICE: WILSON BROTHERS TO THE TOWN OF BARRE, DATED 18 OCTOBER 1907. THE TOWN PAID \$104.50 FOR THE 1.9 ACRE PARCEL. THE LAND BELONGED TO THE "WILSON FARM" SO-CALLED AFTER ITS OWNERS, THE WILSON NAME BEING DESIGNATED TO THE OVERALL CEMETERY. THE DEED HAS A BEARING AND DISTANCE DESCRIPTION AND C. N. BARBER SHOWED THE PROPERTY ON HIS PROPOSED CEMETERY EXPANSION PLAN DATED AUGUST 1907. THE AREA COVERED BY THIS DEED INCLUDES OLD YARD 1, OLD YARD 2, OLD YARD 5, AND THE EAST SECTION.
- F. BOOK 13, PAGE 369 IN THE BARRE TOWN CLERK'S OFFICE: FRANK P. BANCROFT, ADMINISTRATOR OF THE ESTATE OF HELEN M. CUTLER TO THE TOWN OF BARRE, DATED 25 JUNE 1921. THE PROPERTY SOLD FOR \$350, THE ACREAGE NOT SPECIFIED. THE DEED DID NOT SPECIFY ANY BEARINGS AND DISTANCE, BUT RATHER THE NAMES OF LAND OWNERS ALONG THE EDGES OF THE PARCEL BEING SOLD. THE WILSON CEMETERY IS LISTED ON THE NORTH, SOUTH, AND EAST, THE HIGHWAY [GRANITEVILLE ROAD] ON THE WEST. AS THE CEMETERY SHOWED ON THREE SIDES, THIS PARCEL WOULD FILL IN THE REMAINING AREA ON THE WEST SIDE OF THE SITE. THE DEED SPECIFIED THE LAND WOULD BE USED FOR CEMETERY PURPOSES. SECTIONS MAIN AND G ARE WITHIN THIS DEED.
- G. BOOK 64, PAGE 408 IN THE BARRE TOWN CLERK'S OFFICE: GEORGE K. AND ALICE G. THURSTON TO THE TOWN OF BARRE, DATED 31 DECEMBER 1973, 12.1 ACRES FOR \$1 AND OTHER VALUABLE CONSIDERATION. THE DEED CONTAINS A BEARING AND DISTANCE DESCRIPTION. TOWN OFFICIALS HAD AN EXPANSION PLAN IN MIND FOR THIS PARCEL AND HAD DONE EXPLORATION AND SOIL BORINGS PRIOR TO PURCHASING THE LOT. A SEPARATE PLAN SHOWS THE EXPANSION AND DEEMS THE LAND SUITABLE FOR A CEMETERY. NEW SECTION A, NEW SECTION B, AND A LARGE AMOUNT OF UNDEVELOPED LAND ARE COVERED BY THIS DEED.
