Professional Agreement between: Chelsea Ray, MD, & Alger County Medical Examiner Services

This Agreement made and effective this 1st day of June, 2020, by and between Chelsea Ray, MD, and Alger County Board of Commissioners will be for the purpose of establishing a system for Chelsea Ray, MD, to provide Medical Examiner Services to Alger County.

In accordance with ACT 181 of 1953, County Medical Examiners:

- (1) The board of commissioners of each county of this state shall by resolution abolish the office of coroner and appoint a county medical examiner to hold office for a period of 4 years. If the office of county medical examiner becomes vacant before the expiration of the term of office, the board of commissioners may appoint a successor to complete the term of office. In counties with a civil service system, the appointment and tenure of the medical examiner shall be made in accordance with the provisions of that civil service system.
- (2) County medical examiners shall be physicians licensed to practice within this state or, if the county does not have an accredited hospital, licensed in another state that borders the county.
- (3) Two or more counties, by resolution of the respective boards of commissioners, may enter into an agreement to employ the same person to act as medical examiner for all of the counties.

ME Responsibilities

- The Alger County Medical Examiner's Office serves the residents of Alger County by issuing permits and death certificates, approving cremations, and conducting medical investigations on all unexplained deaths throughout the entire Alger County area.
- MEs work closely with the funeral homes, physician offices, hospitals, EMS, and local law enforcement agencies to get a complete record of information on each individual that goes through the ME Office.
- The Medical Examiner will be immediately available to investigate any sudden, violent, unexpected or suspicious deaths that occur in Alger County, and to perform any and all statutorily prescribed duties set forth in MCL 52.201, et seq., regardless of whether specifically listed herein.

ALGER COUNTY Responsibilities

Fees: In consideration for services, Alger County shall pay Chelsea Ray, MD \$12,000 annually. Payments of \$1000 will be due no later than 15 days following the end of the month. These fees shall include any and all actual and necessary travel and other expenses authorized under MCL 52.201e incurred by the Medical Examiner in the performance of his duties.

INDEPENDENT CONTRACTOR

The Medical Examiner shall be an independent contractor and shall not be deemed an employee of Alger County for any purpose.

AMENDMENT

This Agreement may be modified or amended by mutual assent of the parties hereto, and such modifications will be attached to and become a part of this Agreement.

TERMINATION

This Agreement commences with an effective date of June 01, 2020 for a period of four (4) years, expiring on May 31, 2024, unless terminated sooner by any party. This Agreement is in effect with Chelsea Ray, MD, and will not transfer responsibility should Chelsea Ray, MD, cease practice in Alger County.

This Agreement between Alger County and Chelsea Ray, MD, can be terminated at any time, with or without cause, given 60 days written notice by either party. Provided, however, that a hearing shall first be conducted as required under MCL 52.201f if it is claimed that the Medical Examiner has failed to properly discharge the duties of his office.
