Iowa Code section 21.4 requires that each Access Advisory Board meeting shall be held at a place reasonably accessible to the public and at a time reasonably convenient to the public, unless for good cause such a place or time is impossible or impracticable. Given Mayor Cownie's March 17, 2020 Proclamation, as amended, Prohibiting gatherings of ten or more persons on public property, and the City Manager's decision to delay the opening of City buildings to the public to March 1, 2021 due to the spike of COVID -19 cases and hospitalizations in Polk County, and further given Section One of the Governor's January 7, 2021 Proclamation strongly encouraging vulnerable Iowans to limit participation in gatherings of any size and any purpose during the COVID -19 outbreak and further given Section 117 of said Governor's Proclamation suspending the regulatory provisions of Iowa Code §§ 21.8, 26.12, and 414.12, or any other statute imposing a requirement to hold a public meeting or hearing, the Access Advisory Board has determined that a meeting at a physical place is impossible or impracticable and all Access Advisory Board meetings for the time being will be conducted electronically with the public allowed to attend per the instructions on this agenda. Meeting minutes will continue to be provided per the City's normal course of business.
