## ORDINANCE NO. 2006-4

An Ordinance to designate an enforcing agency to discharge the responsibility of the County of Missaukee, under the provisions of the Stille-DeRossett-Hale Single State Construction Code Act, 1972 PA 230.

The County of Missaukee ordains:

### Section 1. Agency Designated.

Pursuant to the provisions of the Michigan Building, Electrical, Mechanical, and Plumbing Code, in accordance with Section 8b(6) of 1972 PA 230, the Plumbing Code Official of the County of Missaukee is hereby designated as the enforcing agency to discharge the responsibility of the County of Missaukee under 1972 PA 230, State of Michigan. The County of Missaukee assumes responsibility for the administration and enforcement of said Act throughout its corporate limits.

### Section 2. Repeals.

All ordinances inconsistent with the provisions of this Ordinance are hereby repealed.

### Section 3. Publication.

This Ordinance shall be effective after legal publication and in accordance with provisions of the Act governing same.
