A MOTION TO RESCIND A MOTION OF July 9, 1973, CONCERNING THE ESTABLISHMENT OF A PLANNING COMMISSION FOR THE COUNTY OF MISSAUKEE, MICHIGAN

Com. VanderHeide moved, supported by Com. Diemer as follows:

WHEREAS, There occurred a misunderstanding based upon a letter from the Office of Economic Expansion suggesting that the Planning Commission should be appointed by Resolution, and

WHEREAS, The County Board of Commissioners took action to change the 1970 Ordinance to a Resolution, and

WHEREAS, The 1970 Ordinance was and is the proper action; and

WHEREAS, The 1970 Ordinance was approved by the Governor;

NOW THEREFORE, The Missaukee County Board of Commissioners hereby rescinds the action taken on July 9, 1973, whereby Ordinance 70-1 was corrected to read "Resolution" and gives full effect to Ordinance 70-1 as adopted on January 12, 1970. Said Ordinance which reads as follows:

RESOLUTION TO DELEGATE THE DUTIES OF A ZONING COMMISSION TO THE MISSAUKEE COUNTY PLANNING COMMISSION

Com. VanderHeide moved, supported by Com. Bosscher as follows:

WHEREAS, The County of Missaukee has duly created the Missaukee County Planning Commission as prescribed by Law, and

WHEREAS, A function of said Commission is to make careful and comprehensive studies of the existing conditions and probably growth within the County and to develop a plan to guide and accomplish a coordinated, adjusted and harmonious development to best promote the health, safety, order, conscience, prosperity and the general, welfare of the inhabitants, and

WHEREAS, It is a function of zoning regulation to promote the aforesaid objectives.

BE IT THEREFORE RESOLVED, Pursuant to the provisions of Act 113 of the Public Acts of 1972, that all powers, duties and responsibilities for a Zoning Commission, prescribed by the Act 183 of the Public Acts of 1943, as amended, being sections 125, 201, to 125.232 of the Compiled Laws of 1948, be hereby delegated to the Missaukee County Planning Commission.

Any and all acts done and performed by the Missaukee County Planning Commission, authorized by the motion of the Missaukee County of Board of Commissioners, adopted February 5, 1973, and July 9, 1973, are hereby approved, confirmed, ratified and adopted.
