ORDINANCE TO ADOPT FIFTH AMENDMENT TO THE MISSAUKEE COUNTY
INTERIM ZONING ORDINANCE

Com. VanderHeide moved, supported by Com. Gillow to adopt Amendment #5 to the Missaukee County Interim Zoning Ordinance as follows:

ORDINANCE NO. 75 Z-3

An Ordinance to amend parts of the Missaukee County Interim Zoning Ordinance adopted August 20, 1973, as amended.

The County of Missaukee Ordains:

Item 1: Whereas The official map of the Missaukee County Interim Zoning Ordinance of August 20, 1973, as amended, is a part of that Ordinance as provided by Section 2.02.

Whereas Changes in Districts by re-zoning constitutes an amendment to said Ordinance.

Therefore The official map of the Missaukee County Interim Zoning Ordinance dated August 20, 1973, as amended, is hereby amended to show changes made in districts as follows:

A. Aetna Township – NW1/4 of NE1/4 and N1/2 of SW1/4 of NE1/4 Section 32 from Agricultural AG to Forest Recreational FR District.

B. Bloomfield Township – NE1/4 of NW1/4 of Section 34 from Forest Recreational FR to Agricultural AG District.

C. Butterfield Township – S1/2 of SW1/4 of NW1/4 of Section 23 east of the Muskegon River only from Forest Recreational FR to Forest Agricultural FA District.

D. Caldwell Township – S1/2 of SW1/4 and S1/2 of NE1/4 of Section 14 from Forest Recreational FR to Agricultural AG District.

E. Caldwell Township – Dyer Lake Plat (Plat Book pages 10, 12 and 13) in Sections 22, 23 26 and 27 to correct designations on map from Residential R2 to Residential R3 Districts.

F. Clam Union Township – N1/2 of NW1/4 of Section 34 from Agricultural AG to Forest Recreational District FR.

G. Lake Township – SE1/4 of NW1/4 of Section 36 from Forest Recreational FR to Residential R2 District.

H. Richland Township - N1/2 of N1/2 of NE1/2 of Section 21 from Agricultural AG to Forest Agricultural FA District.

I. West Norwich Township – W1/2 of NE1/4 of NW1/4 of Section 15 from Agricultural AG to Forest Agricultural FA District.

J. West Norwich Township – E1/2 of NE1/4 of NW1/4 of Section 15 from Agricultural Ag to Forest Agricultural FA District.

K. West Norwich Township – SW1/4 of SW1/4 of SW1/4 of Section 16 from Forest Recreational FR to Forest Agricultural FA Districts.
